## **Journals**

Our journal portfolio continues to grow, and we have much to be proud of, including winning the Independent Academic and Professional Publisher of the Year 2024 award. This year we launched the *Journal of Global Ageing* and announced another new journal, *Gender and Justice*, which will launch in 2025. Many of our journals are interdisciplinary and aim to encourage debate across academic silos. As our list grows, we have become particularly strong in the fields of Sociology, Political Science, International Relations and Public Policy.

We're also delighted that two of our journals are now ranked in the top quartile of the 2024 Journal Citation Reports. Our oldest journal, *Policy & Politics*, is ranked in the top quartile for both Political Science and Public Administration. After only seven years of publication, the *European Journal of Politics and Gender* is ranked in the top quartile for Gender Studies. Nine of our journals are now in the first or second quartile of rankings in their relevant categories in the 2023 Journal Citation Reports (JCR).

This year, our flagship fully open access *Global Social Challenges Journal* (GSCJ) was accepted into the LYRASIS Open Access Community Investment Program (OACIP). OACIP is a framework which allows community stakeholders, such as libraries and academic departments, to evaluate and collectively fund diamond open access journals. We are hoping that with support from our community we can convert the journal to Diamond open access. You can learn more about supporting GSCJ on page 5.

Our Read and Publish agreement continues to gain traction with institutions and consortia. Last year, we expanded the agreement worldwide and already have deals in place with major consortia. Aimed at being as equitable a route to open access as possible with uncapped publishing and affordable, straightforward pricing, the offer has proven popular with the library community. 
Gender and Justice is an international and transdisciplinary journal dedicated to advancing critical feminist scholarship on justice in the social sciences, and from different methodological perspectives.
